# The Ogmore Lodge History 1878 – 2007

The Ogmore Lodge No.1752 was consecrated on the 2<sup>nd</sup>.July 1878 at the Masonic Hall, Adare Street, Bridgend.

There were two meetings prior to this date, the first being held at the Wyndham Arms Hotel, Bridgend on the  $22^{nd}$ .May, 1878, the second at the same address on the  $22^{nd}$ .June 1878.

It is obvious that there must have been several meetings before these dates as the Most Worshipful The Grand Master His Royal Highness Albert Edward, Prince of Wales, granted the Warrant on the 24<sup>th</sup>.day of April 1878.

The first Worshipful Master was John Sim Wooley, who was initiated in St.Teilo Lodge No.695, which is no longer in existence.


He was a member of the Indefatigable Lodge No.237 in Swansea in 1863, and was its Master in 1877.

He was appointed Provincial Grand Director of Ceremonies in 1878, and according to the records he was a Commercial Traveller and performed ceremonies in Lodges which he visited.

He was nominated as Worshipful Master of The Ogmore Lodge at a meeting held on 22<sup>nd</sup>.May 1878, together with the following founder members:-

With the exception of Bro.J.S.Wooley and Bro.W.Podmore the remaining Founder Members were all members of the Avan Lodge No.833 and, in addition, further names are recorded, namely Bro.George Morley and Bro.W.Lewis.

No record of the Lodge, which has sponsored its formation, is recorded in the Minutes and it is assumed that the Avan Lodge No.833 was responsible.

Unfortunately, Afan Lodge Minute Books prior to 1916 have been lost. However, the Grand Secretary has confirmed that the Afan Lodge No.833 were the sponsors and, indeed, ten Founders were members of that Lodge.

Before proceeding further, I feel it is worth noting that the Lodge was in being in the town of Bridgend in 1765 – 1774. Hereunder is an extract from Lanes Masonic Records 1717 – 1794.

#### "Bridgend Lodge 1765 - 1774 No.33

No return of Members was sent to by Bridgend Lodge after 1774 and evidently after that year the Lodge collapsed.

An attempt appears to have been made 1n 1777 to revive the Lodge, and on 25<sup>th</sup>.October 1777, a new Warrant was granted to our well beloved brethren th W.Bro.Richard Price, the W.Bro.David Jones, his Senior Warden, and W.Bro.Jenkin Williams, his Junior Warden, to form and hold a Lodge of Free and Accepted Masons aforesaid at the sign of the Bear or any other place in the town of Bridgend, Glamorgan, on the first day in every calendar month.

Richard Price's name at the head of the list to Grand Lodge for 1765. There is no record that the Lodge was constituted, although a Warrant was issued for the purpose. Neither is there any reference in the Minutes of Grand Lodge respecting the issuing of this particular Warrant nor of the usual fee having been paid. Further proof of the non-existence of the Lodge appears to be furnished from the fact its number does not appear in the first known list of the Ancient Lodges published in 1791, nor any subsequent list until after the formation of Glamorgan Lodge in 1808.

Yet it is quite clear that a Warrant was issued in 1777. The parchment is still in existence and is the one under which Glamorgan Lodge still holds its meetings.

Richard Price was born at Tynton in the parish of Llangeinor on the 23<sup>rd</sup>.February, 1723, and died in London on 19<sup>th</sup>.April, 1791. Philosopher and apostle of liberty, F.R.S., D.D., LL.D, Founder of Life Insurance, father of old age pension, prophet of League of Nations, honoured by Congress U.S.A. etc, etc"

In this Province we have to day two Lodges which were originally "Antient Lodges – Glamorgan Lodge No.36 Cardiff, which now works under the Warrant issued to Bridgend in 1765; No.33. The other being Loyal Cambrian Lodge No. 110. Merthyr Tydfil.

The Bridgend Lodge was erased from the books of Grand Lodge in 1774.

### **The Consecration**

The consecration of the Ogmore Lodge No.1752 took place on Tuesday, 2<sup>nd</sup>.July, 1878, at the Wyndham Arms Hotel, Bridgend, at twelve noon.

The Lodge was opened in due form by W.Bro.W.T.Canton, Prov.G.Treasurer of Indefatigable Lodge No.237, assisted by officers and members of his Lodge.

The Worshipful. Deputy Provincial Grand Master, W.Bro. Marmaduke Tennant and officers being announced entered the Lodge and took up their respective places. Provincial Grand Lodge was then opened in the customary manner.

W.Bro. Mathew Wayne Morgan of the Merlin Lodge, Prov.G.Supt.Works, on behalf of the petitioners requested the Deputy Provincial Grand Master to consecrate the Ogmore Loidge No.1752.

The acting Provincial Grand Registrar read the Warrant of Constitution; the Deputy Provincial Grand Master consecrated the Lodge according to the antient custom in a solemn and impressive manner. The Worshipful Master designate was then introduced to the Deputy Provincial Grand Master for the benefit of Installation as the first Master of Ogmore Lodge.

The ceremony was duly carried out and the officers previously enumerated were invested. Twelve gentlemen were then proposed as candidates.

Between 1876 and 1900 a period of 24years, there are only 160 members recorded in the register, and in the Millennium year of 1900, in July 1900, Bro.James Pratt McGual was installed into the Chair of King Solomon. It is interesting to note that the Installation took place in the month of July, where currently the traditional month is now October.

Bro.James Pratt McGual was the 139<sup>th</sup>.member, and was Initiated on 2<sup>nd</sup>.February 1896, Passed 23<sup>rd</sup>.March 1896 and Raised 28<sup>th</sup>.December 1896. His Grand Lodge Certificate Number 1079 was presented to him on 26<sup>th</sup>.April 1897.

## The Bridgend Masonic Hall – Wyndham Street, Bridgend.

At the Regular Lodge held on the 26<sup>th</sup>.October, 1885, W.Bro.John Blandy Jenkins proposed and Bro.L. Beha seconded a Masonic Hall be built for the Ogmore Lodge, and a committee be formed of the following brethren: John Blandy Jenkins, L.Beha, J.W.Pritchard, J.Herdman, J.C.Coath, C.E.Perry, S.Collier, E.Price, W.R.Randall, E.Thomas.

No further reference is recorded about this project until 9<sup>th</sup>.April, 1886, when a sub committee was formed to negotiate terms on which the Ogmore Club premises could be acquired and adapted for a Lodge room.

Again, no record was made in connection with this until 28<sup>th</sup>.June, 1886, when the proposal to acquire the premises was dropped.

However a scheme was launched to raise funds to build a hall. At this stage there was a £100.00 available in Lodge funds and members had promised to take shares to the value of £300. Some plans had by this time been prepared which included three sets of offices, the estimated cost of the erection of the building being £800. It was hoped the offices would bring in an income of £36 per annum plus £4 from the Lodge. It was suggested that capital for the building could be raised either by forming a limited company or issuing debentures; alternatively, obtaining a mortgage advance.

The minutes of the Lodge held on 25<sup>th</sup>.October, 1886, record the following:

Bro.Boles reported that he had seen Lord Dunraven with reference to a site for the Masonic Hall and that his Lordship expressed his willingness to grant a site near the National Provincial Bank, free of charge during his lifetime, at the same time making the suggestion that shops should be built under the Lodge room. However, the Deputy Provincial Grand Master called attention to the terms of His Lordship's offer, viz. that the gift of the site was for his lifetime, and suggested some provision should be made by the Lodge for the future, and proposed insurance on His Lordship's life to provide for payment of ground rent after his death.

However a hitch occurred in connection with the raising of funds: the committee recommended the capital required being £2000. should be raised by issuing 400 shares at £5 each which were issued exclusively to members of the Lodge.

From the minutes concerning the building over the next twelve months, it appears they were a turbulent nature, which resulted in instructions being given to wind up the company, which had been formed. Bro.Randall was instructed accordingly on the 25<sup>th</sup>.June, 1888.

Nothing further happened until March, 1890, a new building committee raised its head through Bro.Vaughan and, In April 1890, the company, which was still at this stage in existence, was wound up and the monies subscribed by the shareholders were returned.

On  $6^{th}$ .January, 1891, a new building committee was formed, and at the February Lodge progress was reported; from this point progress was rapid. The committee were empowered to raise the money to erect a building; the sum of £100 was voted from the Lodge funds for a start; how the remainder of the capital required was to be obtained is not recorded. The first indication emerges with a printed account headed "Ogmore Lodge (New Hall) Building Account". Which is attached ti the minutes and was approved at a meeting held on 24<sup>th</sup>.July, 1893; the details are as follows:

It would appear the capital was raised by members making repayable contributions to the value of  $\pounds722 @ 5\%$  interest per annum; further an appeal was made on the  $14^{th}$ .June, 1892, when Bro.Boles made a gift of  $\pounds50$ . It was suggested obtaining a mortgage advance on the security of the building to raise any deficiency.

According to the minutes of the Regular Lodge held on 22<sup>nd</sup>. June, 1891, it was resolved that the details of laying the memorial stone of the Masonic Hall be left to the committee.

On Tuesday, 28<sup>th</sup>.July, 1891, Provincial Grand Lodge was presided over by the Deputy Provincial Grand Master, W.Bro.Marmaduke Tennant; after the business was concluded and Officers appointed, the Lodge was adjourned. The Brethren were formed in procession and, headed by the Tondu Brass Band, proceeded to the site of the new Masonic Hall in Adare Street, where the Deputy Provincial Grand Master laid the memorial stone assisted by officers of Provincial Grand Lodge according to the ancient custom.

The Deputy Provincial Grand Master was presented with a silver trowel and an ivory mallet to mark the historical event. This trowel was returned to the Ogmore Lodge by Bro.Neville Walsh and was presented to the Lodge by W.Bro. Edgar Abrahams of the Avan Lodge No.833 on 16<sup>th</sup>.November, 1958. It is now on display in the new Temple at Coychurch Road, Bridgend, which was built in place of the Adare Street Temple, which was demolished to make way for the new town development in 1968.



# **The Ogmore Lodge Centenary 1978**

From the conception of the Lodge in 1878 to its centenary in 1978 there have been 894 members, and the Centenary Master was W.Bro.Jack Reeves P.Pr.J.G.W., Who was Initiated 23<sup>rd</sup>.November 1964, Passed on 22<sup>nd</sup>.February 1965 and Raised on 24<sup>th</sup>.May 1965.

W. Bro.Jack was Installed into the Chair of King Solomon in October 1977 and celebrated the Centenary on the 3<sup>rd</sup>.July 1978; a copy of the summons is below:

# **The 1978 Centenary Summons**



Between 1878, the Millennium of 1900 and the Millennium of 2000 there have been continual Worshipful Masters, and the accumulative membership has been 1010, and to date March 2007, the total membership has been 1028.

The Millennium Worshipful Master in the year 2000 was W.Bro. Phillip A. Aubrey, who was initiated on 16<sup>th</sup>.December 1991, Passed on the 27<sup>th</sup>.January 1992 and Raised on 24<sup>th</sup>.February 1992.

W.Bro.Phillip Aubrey is the current Secretary of the Ogmore Lodge, and was appointed Acting Provincial Senior Grand Deacon in June 2006.

The late Provincial Grand Master, R.W.Bro.The Lord Swansea, honoured the Ogmore Lodge in appointing the late W.Bro.Ronald Whittingham, as Assistant Provincial Grand Master in 1977 and became a P.Pr.A.G.M. in 1982.

W.Bro. Ron. Attained the Chair of King Solomon in 1953, but unfortunately passed to the Grand Lodge above in 1993.

In 1987 the R.W.Provincial Grand Master, R.W.Bro.The Lord Swansea, appointed W.Bro. Stanley Bernard Roberts to the rank of P.A.G.D.C., W.Bro.Stanley, was also a Past Provincial Grand Master in the Mark Degree.

In 1986 The R.W.Provincial Grand Master, R.W.Bro.The Lord Swansea, appointed W.Bro.Cyril William Shickle, to the rank of P.G.Std.B and W.Bro. Cyril has been subsequently been promoted to P.A.G.D.C. and is to date a long serving Grand Officer of the Ogmore Lodge.

W.Bro. Cyril was originally initiated into the Scottish Constitution, and has celebrated his Golden Anniversary in that Constitution. W.Bro.Cyril became a joining member of the Ogmore Lodge on 25<sup>th</sup>.April 1960, and will be celebrating his Golden Anniversary on 25<sup>th</sup>.April 2010

The Past Treasure of some 21 years of the Ogmore Lodge, W.Bro. Colin E.Mogg, P.Pro.J.G.W. was appointed by the R.W.Provincial Grand Master, R.W.Bro.Hywel Davies as a P.A.G.D.C. in 2006, W.Bro.Colin was also the Provincial Grand Registrar.

I would like to mention that over the past and present years of the Ogmore Lodge, we have been lead by some very hard working Masons; and without offending any of them, by forgetting to mention their names, I would mention one Brother, who served as Secretary in both the old Temple in Adare Street and the New Temple at Coychurch Road, Bridgend, until his passing to the Grand Lodge above, that is the late W.Bro. Alfred J.Worts, P.Pr.J.G.W.

W.Bro. Alf was one of the negotiators of the sale of the old Temple and, the building of the new Temple, of which we have occupied over the past 21 years.

In tribute to all the hard working Masters of the Ogmore Lodge, present and past, I include their names on the following Roll of Honour, and thank them all for allowing both the Brethren and myself since 1878 to the present date in being members of the Ogmore Lodge No.1752
